 - The Battery Tender in the 2006 F550 was replaced.
 - The Hazmat & TRT SCBA units will have the Annual Flow Testing done Feb 11-12.
 - The Hazmat & TRT radio batteries are starting to not hold charge. It was approved to replace all 24 batteries at a cost of \$1,600.
- **Sheriff:**
 - The Sheriff is planning to file for a Communications Grant for Emergency Operations Center equipment. He is expecting to open up the request to area agencies to also make requests. More to follow.
